Membership terms and conditions:

Green Fee Members may play anytime during daylight hours (except during golf course events sanctioned by the Board of Directors); however, upon arrival at the course member (s) must check in with the Clubhouse Manager or the designated starter, for assignment of starting sequence.

The Board of Directors sanctions the use of the course for Ladies' Day every Wednesday and Mens' Day every Thursday. On these days play may be limited to members of the Tomahawk Women's or Men's associations for part or all of the day. Limitations for those days will be posted in the Clubhouse and may change as indicated by Association participation. Additionally, the Board of Directors will sanction the closure of the course during certain days, or portions thereof, for Course Maintenance, Tournaments and Civic Events. Notice of these closures will be posted in the Clubhouse as soon as they are known.

*Applicant(s) agrees to use the facilities with courtesy and respect for all Tomahawk property, Personnel, and rules; specifically.

*All play will be in accordance with course rules, common courtesy, and the etiquette of golf.

*Starting will be governed by the Clubhouse Manager or, if present, the designated Starter.
